NOTIFICATION

Sub: Inviting applications for recognition of affiliated Colleges, Laboratories, Institutions (Fresh and Renewal) as Research Centres for conducting Ph.D. Programme.

Applications are invited from the Laboratories / Institutes and Affiliated Colleges, Laboratories and Institutions located within the territorial jurisdiction of Bengaluru North University which covers Bengaluru Urban District (C.V. Ramannagar, K.R. Puram, Pulikeshinagar, Sarvagnanagara and Mahadevapura legislative Constituencies); Bengaluru Rural district (Doddaballapura, Devanahalli and Hoskote legislative Constituencies); Chikkaballapur and Kolar Districts for recognition as Research Centres for the purpose of carrying out research programme leading to Ph.D degrees of Bengaluru North University in different subjects under faculty of Humanities, Languages, Social Science, Science, Commerce, Management and Education.

Recognising such eligible Colleges / Laboratories and Institutions as centres to guide researchers for Ph.D degree programmes as per the guidelines of Bengaluru University and also as per UGC guidelines subject to the following conditions.

- The Colleges / Institutions offering Post Graduate programmes in the concerned subject / area shall have adequate research facilities and shall confirm to the norms of the University.
- Laboratories of recognised national or other Institutions maintained by the Government of India where research work is going on.
- Research Institutions maintained by State Government or a Quasi Government / Autonomous Institutions recognized by the Central or State Government and where necessary facilities for research and qualified Staff are available to guide research students.



- 4. The faculty must have put in a minimum of 3 (Three) years of independent research experience after Ph.D. with a minimum of two research publications in the refereed journals (other than published from the contents of the Ph.D. thesis)
- Colleges / Institutes should have qualified staff and necessary facilities as per the Regulations governing the Doctoral Degree Programme.

The Colleges, Laboratories and Institutions who have already been recognized as research centres and completed four years by 2018-19 have to submit the application for renewal of recognition along with the prescribed fee.

Applications are being issued at the 'Office of the Registrar, Bengaluru North University' on payment of Rs.1,200/- through a DD drawn in favour of the 'Finance Officer, Bengaluru North University, Bengaluru', from 12-10-2018during working hours. Filled-in application forms are to be submitted to the University in 8 sets along with the prescribed fee of Rs.82, 500/- per subject of Study for fresh recognition and Rs.35, 000/- per subject for continuation of recognition for those Colleges / Institution which have already been recognized. The Colleges, Laboratories and Institution which have not paid the annual fee so far, have to pay annual fee of Rs.13,000/- per annum to seek renewal of recognition.

Colleges / Institutions desirous of seeking fresh recognition to more than one Subject of Study should submit separate application forms along with the prescribed fee. The filled in application forms in all respect along with the prescribed fee in the form of DD drawn in favour of the 'Finance Officer, Bengaluru North University, Bengaluru' (to be remitted by the Colleges / Institution to the University fund on the day of submission of application.

The Institutes / Colleges managed by the State Government or Central Government are exempted from payment of fee. There will be 50% concession in the recognition fee for the Institutions / Colleges managed by SC/ST Managements.

Important Note:

- 1. Incomplete applications (including part-payment) will be rejected and the Expert Committee will not visit such College / Institute.
- The Head of Institutions / Departments of colleges must ensure that full payment of recognition fee through DD shall be paid at the time of submission of application to the University with all necessary documents.
- 3. Once the application is rejected, it will not be considered again.

- 3. Last date to submit penal fess of Rs. 5,000./- 29-10-2018.
